**OVERVIEW:** The Commonwealth receives over 106,000 reports of child, elder, and disabled persons abuse and neglect each year. It is a crime for mandated reporters to fail to file a Report if, in their professional capacity, they have reasonable cause to believe a child, elder, or a person with disabilities is being abused or neglected. Understanding legal obligations, what constitutes abuse and neglect, how to recognize abuse and neglect, steps to filing a report, and knowing what takes place after a report is made are of utmost importance to a mandated reporter and the safety of vulnerable populations.

Also important for mandatory reporters and frontline workers is to be aware of the safety, legal and basic needs resources in their community. Frontline workers are at the forefront of being able to offer timely and critical information about services and programs that can make meaningful impact to people's lives. It is not feasible to meet all needs "under one roof" and it is essential for frontline workers to be knowledgeable of the available safety, legal, and basic needs resources in order to provide high-quality, life-changing referrals to people in need.
